- VII. Staff Report Jennifer Lepisko On 10/9/18 there was a dedication to the YCC Murals Crew at the Visitors Center, much gratitude was given to our hard working students. The 10<sup>th</sup> grade are completing a unit on Latin American literature with the ofrenda project, they will be going to the Silver City Museum on 10/23/18 to do projects that will honor people who have made a significant contribution to Latin America in the arts, sciences, politics, etc. Ofrendas will be displayed on the 3<sup>rd</sup> floor of the student memorial building on 11/2/18.
